**Cancelled visits:** Please provide at least 48 hours' notice to cancel a scheduled service outside of an emergency. Failure to do so will result in a full charge for the cancelled service. This policy also applies to clients who are absent for a scheduled service or activity.

**Grandfathered HCP:** On November 1, 2025, participants with HCP Grandfathered packages will transition to our updated Support at Home services listed here.

**Out-of-scope services.** Services deemed out of scope are not funded through the Support at Home program.

**Minutes allowance:** Participants should allow an additional 15–30 minutes before and after service times to account for traffic and unforeseen delays.

**Agreed price:** This price list outlines Cura's standard service fees. In certain cases, Cura may negotiate a revised price based on specific participant requests or needs. Any agreed price changes will be agreed and documented in your Participant record.
